In exercise of the powers conferred upon me by section 175 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) and of all other powers enabling me in that behalf, I, **BOLA AHMED TINUBU**, GCFR, President, Federal Republic of Nigeria, hereby grant reduced terms of imprisonment and sentence to the following, that is —
